

THE EDMONTON ART CLUB

NOMENCLATURE

The organization shall be known as "The Edmonton Art Club."

AIMS AND OBJECTS

The aims and objects upon which the Edmonton Art Club is founded are as follows:

1. To propagate a generally wider, keener and more cultivated appreciation of the fine arts.
2. To elevate the plane of local artistic effort.
3. To encourage the production of original work among its members by means of its monthly meetings and criticism, and by the holding of exhibitions and co-operation in the sale of work.

CONSTITUTION

For the purpose of government and the proper conduct and discharge of the business of the Club the Executive Committee shall consist of a President, a Vice-president, a Secretary-Treasurer and three elected members.

ELECTION OF OFFICERS

The annual election of officers by ballot shall be held at the regular annual meeting of the club in January of each year, and on that date all previously elected officers shall automatically retire.

COMMITTEE MEETINGS— A QUORUM SHALL

Not less than three officers may constitute a quorum or be otherwise numerically qualified to discharge the business of the Committee.

SECRETARY-TREASURER

The Secretary-Treasurer shall be responsible for all Club funds and property entrusted to him, and shall keep a roll of membership, and also a record of all business transacted by the Club.

GENERAL MEETINGS

General meetings shall be held on the first Thursday of each month at 8 p.m., when routine business may be transacted with a quorum of four members, one being an executive officer.

SPECIAL GENERAL MEETINGS

A special general meeting may be called by not less than five members who shall notify the Secretary-Treasurer of their intention and of the nature of business to be put before the meeting. The Secretary-Treasurer shall thereupon give notice to all members and inform them of the time and place of meeting and the nature of the business to be considered.

MEMBERSHIP

Membership shall be confined to duly qualified artists who produce works of their own composition and execute in the following media:

Oils, Water Colors, Pastels, Black and White, Etching, Engraving, Sculpture.

Applicants for membership are required to submit two or more examples of their work to be passed upon by the committee.

"DULY QUALIFIED"

"Duly Qualified" applies to all candidates for membership who have satisfied the Executive or Subsidiary Committee appointed by the Executive, that they have sufficiently mastered the prescribed media to warrant admission to membership on the roll of the Edmonton Art Club.

ASSOCIATE MEMBERS

Applicants, at the discretion of the Executive Committee, may be elected as associates until such time as the Committee have satisfied itself that their work comes up to the required standard. Associate Members shall have all privileges of the Club except

that of voting. The Executive Committee shall meet once a year prior to the annual business meeting to consider the election of Associates to full membership.

FEES

Members and Associate members shall be required to pay an entrance fee of one dollar (\$1.00) and an annual subscription of three dollars (~~three~~). A member whose fees have not been paid by the first Thursday in March shall not be considered in good standing to exhibit at the annual exhibition. In the event of non-attendance or failure to produce work, the Executive Committee may after twelve months take under consideration and delete the defaulting member's name from the roll, after having given notice of such procedure to the member in question.

Non-Resident Members

Non-resident members shall pay an initiation fee of one dollar (\$1.00) and a subscription of three dollars (\$3.00) per annum.

AMENDMENTS TO CONSTITUTION

Notice of motion for amendment of any of the foregoing clauses shall be made at a previous general meeting. In voting on a motion for amendment, a majority of two-thirds of those present at the meeting must be secured in favor of the amendment before it can be adopted.
